7. to be aware that the exercise of motor sport activity, by its own nature, entails taking of risks, including serious, of damage to persons and property;
8. to have instructed the minor in relation to all the rules of education, safety and caution required for properly exercise the motor activity also at competitive level and to undertake, during the use of the racing track, to abide by all the instructions given by the S.I.A.S. S.p.A. personnel in charge of surveillance and supervision of the racing track itself;
9. that the minor is healthy and has never suffered, not even occasionally, from pathologies and/or handicap that may make the motor activity that he or she is going to do impossible or more dangerous, and that he or she is in normal psycho-physical conditions and is authorised to drive in accordance with the current provisions of law and regulations of the competent national and international sports authorities;
10. to have instructed the minor to adapt his or her driving behaviour to the weather conditions and the condition of the road surface;
11. that the use of the racing track, which is limited to the purchased time span, is not exclusive and is, in any case, subject to the right of S.I.A.S. S.p.A. to suspend it at any time deemed to be appropriate;
12. to assume all responsibility for any damage caused to property and/or persons resulting from the use of the track;
13. to exempt S.I.A.S. and its staff, the Italian Automobile Club, the Automobile Club of Milano, the Municipalities of Milan and Monza from any liability for any physical damage and/or financial loss that may be caused to the undersigned and/or the vehicle driven by him/her [even if owned by third parties, exempting and indemnifying the above mentioned persons from any claim that may be made for any reason by the third party owner] by carrying out the above activity;
