GENERAL TERMS AND CONDITIONS

The undersigned:

1. Declares to have read, during the Safety Briefing, the regulations governing both the use of the track and that of the racetrack, expressly approving their contents and committing to fully applying them;
2. Undertakes, while using the track, to observe all instructions given during the Safety Briefing by the S.I.A.S. personnel in charge of the monitoring and supervision of the track itself;
3. Undertakes to adapt his driving conduct to the weather conditions and the state of the road surface;
4. Acknowledges that the use of the track, limited to the reserved period of time, takes place on a non-exclusive basis and is, in any case, subject to the right of S.I.A.S. and/or the appointed parties to suspend it at any time it is deemed appropriate;
5. Declares that the vehicle used is perfectly suitable for the sporting use referred to in this contract, that the driver is in normal psychophysical conditions and is qualified to drive the same in accordance with the legal provisions in force;
6. Declares to assume all liability for any damage caused to things and/or persons as a result of the use of the track;
7. Therefore exempts S.I.A.S. S.p.A. and/or its appointees and the personnel in charge, the Automobile Club of Italy, the Automobile Club of Milan, the Municipalities of Milan and Monza from any liability for all physical and/or financial damages that may be caused to the undersigned and/or to the vehicle he/she drives (even if owned by third parties, excluding and guaranteeing the aforementioned from any claims that may be made for whatever reason by the third party owner), from carrying out the aforementioned activity;
8. Undertakes to use, in accordance with the regulations in force, a helmet homologated according to Italian Street Regulation, exempting S.I.A.S. S.p.A. from any liability arising from failure to comply with this undertaking;
